

**OAK GROVE CEMETERY
VILLAGE OF WEBSTER
February 20, 2013 Minutes**

The Oak Grove Cemetery Board Meeting was held on Wednesday, February 20, 2013 at 6:00 p.m. at the Village of Webster Office for the purpose of the Bi-Yearly Regular Meeting.

Present were: Village President, Jeff Roberts; and Members; John Mulroy, Mark Foote, Paula Smith, Jack Swedberg and Secretary-Treasurer, Patrice Bjorklund.

Others present were: Judy Foote

Absent were: Members, Billy Janssen and Jim Olson.

Minutes from the June 28, 2012 Regular Meeting was read. Motion to approve was made by Member, Foote; seconded by Member, Swedberg. Motion carried 6-0.

Treasurer's Report: Treasurer's Report was read. Motion was made to approve the Treasurer's Report by Member, Smith; seconded by Member, Mulroy. Motion carried 6-0.

Subject: Cemetery Worker, Ray Hammerschmidt's pay was discussed. Village President, Roberts asked if he intends on coming back. Secretary-Treasurer, Bjorklund stated that he had not stated otherwise. His current pay is \$10.50 per hour. Motion was made by Member, Swedberg to increase his pay to \$11.00 per hour; seconded by Member, Smith. Motion carried 6-0.

Subject: Tree removal discussion took place. Member, Foote would like to see trees removed that are damaged and clean up the overgrown trees at Oak Grove Cemetery. Member, Swedberg doesn't want all the trees removed. He stated that the damaged trees are what he would prefer removed from the cemetery. Village President, Roberts asked Secretary-Treasurer, Bjorklund to speak with Public Works Director, Jay Heyer and see if T & P Logging would look over and give a proposal. The consensus of the board was to have T & P Logging look over the north-end of the cemetery (old section) remove and haul away the damaged trees and give a proposal to do so. Member, Foote and Member, Swedberg both wanted them removed to protect headstones in the cemetery.

Also, the board asked Secretary-Treasurer, Bjorklund to notify Ross Tollander and see if the next time he's digging a grave if he could flip over the burn pile and stir up trees and debris for burning.

There being no further business, the meeting was adjourned on a motion by Member, Foote; seconded by Member, Mulroy at 6:24 p.m. Motion carried 6-0.
