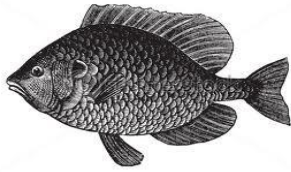


# CAUCUS MEETING MINUTES

There were none. Motion to close nominations for Village Trustee’s was made by Charlie Weis, and seconded by Tim Maloney. **Motion carried 7-0.**
- V. **LOT DRAWING FOR BALLOT ORDER PLACEMENT** – Kelsey Gustafson will be placed 1<sup>st</sup> on the ballot. Greg Widiker will be placed 2<sup>nd</sup> on the ballot. Sarah Casady will be placed 3<sup>rd</sup> on the ballot.
- VI. **ADJOURNMENT.** Motion was made by Trustee, Widiker to close the caucus at 5:52 p.m., seconded by Trustee, Weis. **Motion carried 7-0.**
