- I. **CALL TO ORDER** – Village President, Jeff Roberts called the meeting to order at 5:45 p.m.
- II. **PRESENT** – Trustee, Kelsey Gustafson; Trustee, Tim Maloney; Trustee, Darrell Sears; Trustee, Bill Summer; Trustee, Charlie Weis; Trustee, Greg Widiker; Becky Strabel, Inter-County Leader; Police Officer, Noah Barker, Aaron Sears, Tom O’Brien, Robin Blomberg, Public Works Director, Jay Heyer and Clerk-Treasurer, Debra Doriott-Kuhnly. Absent: None.
- III. **OPENING OF NOMINATION OF CHAIRMAN FOR CAUCUS** – President, Roberts asked for nominations for Chairman of the Village of Webster Caucus. Motion was made by Tim Maloney to nominate Jeff Roberts; seconded by Kelsey Gustafson. **Motion carried 6-0.**
- IV. **NOMINATION REQUEST BY BALLOT OR VOTE OF HANDS** – Motion made by Tim Maloney to nominate request by vote of hands; seconded by Charlie Weis. **Motion carried 6-0.**
- V. **NOMINATION OF VILLAGE PRESIDENT** – Chairman, Roberts asked the audience for nominations for Village President. Charlie Weis nominated Jeff Roberts for Village President; seconded by Kelsey Gustafson. **Motion carried 6-0.** Bill Summer nominated Kelsey Gustafson for Village President. Gustafson declined. Chairman, Roberts asked the voting public if there were further nominations for Village President. There were none. Motion to close nominations for Village President was made by Charlie Weis and seconded by Darrell Sears. **Motion carried 6-0.**
- VI. **NOMINATION OF VILLAGE TRUSTEES** – Chairman, Roberts stated there are three positions opened for Village Trustee and opened nominations. Motion was made by Charlie Weis to nominate Tim Maloney as Village Trustee, seconded by Greg Widiker. **Motion carried 6-0.** Motion was made by Darrell Sears to nominate Aaron Sears as Village Trustee, seconded by Jeff Roberts. **Motion carried 6-0.** Motion was made by Bill Summer to nominate Kelsey Gustafson as Village Trustee. Gustafson is not up for nomination- his term expires in 2022. Motion was made by Tim Maloney to nominate Charlie Weis as Village Trustee, seconded by Greg Widiker. **Motion carried 6-0.** *Darrell Sears will not be seeking reelection.* Chairman, Roberts asked the voting public if there were further nominations for Village Trustees. There were none. Motion to close nominations for Village Trustees was made by Charlie Weis and seconded by Darrell Sears. **Motion carried 6-0.**
- VII. **LOT DRAWING FOR BALLOT ORDER PLACEMENT** – Aaron Sears will be placed 1<sup>st</sup> on the ballot. Tim Maloney will be placed 2<sup>nd</sup> on the ballot. Charlie Weis will be placed 3<sup>rd</sup> on the ballot.
- VIII. **ADJOURNMENT.** Motion was made by Trustee, Widiker to close the caucus at 5:51 p.m., seconded by Trustee, Sears. **Motion carried 6-0.**
