Discussed draft 2025 IUOE Agreement.

- Housekeeping of contract
 - 1. Article 2- remove Director of Public Works
 - 2. Article 4 delete entire article (training, licensing,05¢/hour would go away)
 - 3. Article 11 delete section E
 - 4. Article 16 date changes
- Article 24- Significant increase in health insurance for 2025. 2024 was \$1837 with Village paying \$1653.30. 2025 will be \$1926 with Village paying \$1733.40 (increase of \$89/month). Coverage remains the same.
- Article 12: Wages CPI is 3.30% for 2025. \$22.46 to \$23.20/hour
- Article 25: Retirement Pension contribution at \$4.50/hour; asking for \$5.00/hour
 - 1. Village can consider creating a new classification for Kuhnly's position; which would allow the Village to increase her hourly rate. Could also consider giving her a bonus. The committee will review and discuss.

Discussed Director of Public Works Position.

- Phernetton is retiring on December 31, 2024.
- The committee discussed various options moving forward and the final plan to be completed ASAP. Also need to talk to Thompson regarding his position.
